Grove Software Sales Policy

- MicroShield®, RadDecay®, and MicroSkyshine® are only sold as subscription licenses and the software is leased for the term of one year (quotations for longer terms are available). After the term is over, you will need to re-subscribe to continue to utilize the software.
- MicroShield® V&V is sold as a perpetual license.
- Subscription Licenses include access to support services and **all new versions** of the software as they are released as long as the subscription is active.
- Local Area Site Licenses permit unlimited installations within a 25 mile (40 km) radius.
- Wide Area Site Licenses permit unlimited installations.
- Site License installations are only for the purchasing company only and does not include subsidiaries, subcontractors, or any other entities.
- All software products have a single user, single machine license.
- **All software products are ONLY sold under Grove Software license agreements (i.e. terms and conditions).**
- Applicable sales tax will be added unless you provide tax exempt documentation.
- Grove Software is not responsible for collection of VAT or GST. International shipments must include the VAT registration number (or equivalent) for delivery. UPS® will collect any VAT or GST fees upon delivery.
- **Credit card, business check, ACH draft, or wire transfer is required and will be authorized before shipment.**
