- Local Area Site Licenses permit unlimited installations within a 25-mile (40 km) radius.
- Wide Area Site Licenses permit unlimited installations.

Grove Software Sales Policy

- All software products are sold as subscription licenses, and the software is leased for the term of one year (discounted quotations for longer terms are available). After the term is over, you will need to re-subscribe to continue to utilize the software.
- **All software products are ONLY sold under Grove Software license agreements (i.e., terms and conditions). If additional commercial terms are requested, these terms need to be approved by Grove Software and this pricing sheet may not be valid to accept the additional commercial terms.**
- The Initial Price is the pricing for the first licensing term and future terms will be based on the Renewal Price **only if the renewal occurs prior to the end of the active subscription term.**
- Subscription Licenses include the software licenses, access to support services, and all new versions of the software as they are released if the subscription is active. **Software updates will only be provided for the latest version of the software products.**
- **Site License installations are only for the purchasing company (legal entity) only and do not include subsidiaries, subcontractors, or any other entities.**
- The Site Licenses may include the option for Local License Management. These licenses will allow the end user to locally manage software keys and licensing without external, internet-based authorization. This license is not available to export to all countries.
