Grove Software Sales Policy

- MicroShield® Pro, MicroShield® LT, MicroShield® V&V, RadDecay®, and MicroSkyshine® are sold as subscription licenses and the software is leased for the term of one year (discounted quotations for longer terms are available). After the term is over, you will need to re-subscribe to continue to utilize the software.
- Subscription Licenses include installation onto one machine, access to support services, and ***all new versions*** of the software as they are released as long as the subscription is active.
- Site License installations are only for the purchasing company only and does not include subsidiaries, subcontractors, or any other entities.
- The Site Licenses for MicroShield®, MicroShield® V&V, RadDecay®, and MicroSkyshine® include the option for Local License Management. These licenses will allow the end user to locally manage software keys and licensing without external, internet-based authorizations.
- ***All software products are ONLY sold under Grove Software license agreements (i.e. terms and conditions).***
- Applicable sales tax will be added unless you provide tax exempt documentation.
- Grove Software is not responsible for collection of VAT or GST. All software will be delivered electronically from our website.
- ***Credit card, business check, ACH draft, or wire transfer is required and will be authorized before shipment.***
